ATTENDEES: Are you a school leader, administrator, teacher, instructional staff, counselor, social worker, Title1 or special education personnel? Then you should attend NDCEL's Fall Education Super Conference. We are striving to provide National quality professional development tailored to North Dakotas' educators!

REGISTRATION: The 2020 registration fees will be the same for all attendees regardless of your membership with NDCEL or it's affiliates. There will be graduate credit available to attendees but attendance and check-in on all 3 days is required. (Pre-conference Wednesday 4:30pm-6:30pm, Thursday 8am-5:30pm, and Friday 8:30am - 3pm).

Registration opens on April 1, 2020 and will close on October 19, 2020 at 5:00pm. There will be onsite registration available for an additional \$50. There will also be options to attend a single day of conference, but there is \$150 in savings by attending the full 3-day conference!

Meals are NOT provided during the conference. There will be light appetizers at the socials. The Bismarck Event Center will have concession stands for breakfast, lunch and snacks, available for purchase.

PRESENTORS: Please visit the Call For Proposals page on the [NDCEL website](#) to submit your breakout information. This opens March 16th and will close July 1, 2020. Any and all presenters will be required to fill out the Call For Proposal in order to host a break-out session at the 2020 NDCEL Fall Administrators Conference. Presenters must register for the conference if you are presenting, there are no discounts for presenters. You will be notified with a decision regarding proposals by July 31, 2020. If accepted you will receive instructions for next steps. All presentation details must be submitted by September 1, 2020 to be printed on the conference program/agenda.

EXHIBITORS: Exhibitor booths will be accepted on a first come, first serve basis. Vendor registration opens on April 1, 2020 and will close when all spots are full. Exhibitor set up will be Wednesday October 21, at 2:30pm with the Exhibitor Vendor Show open from 7am- 5:30pm Thursday, October 22nd. Each exhibitor will be given a 10x10 space with pipe and drape, an uncovered 8ft table, power access and a secure wifi code. The cost of an exhibitor booth is \$650. You will be notified of specific set up instructions via email closer to the event.

Wednesday Pre-Conference Only (4:30pm-6:30pm) - \$75
